Two disinfectants of different modes of activity can be provided on a rotated schedule to meet regulatory expectations. A sporicidal disinfectant is incorporated into the schedule as well.

## **HUMAN RESOURCES**

anitronics complies with all rules and regulations set forth by the United States Department of Homeland Security as they pertain to employment eligibility verification. All individuals must have their employment eligibility validated via Form I-9 on the day they are hired. Janitronics participates in E-verify and also maintains a tracking system for those employees whose employment eligibility must be re-verified in accordance with the Homeland Security Act.

Employees are informed of the re-verification process in advance by personal letters as to their status. They are notified of the steps that must be taken prior to their expiration dates. This avoids any hindrances on operations if the employee cannot continue to work.





We utilize SecureHire from ADP which includes instant Social Security number validation, as well as federal, state and county felony criminal history checks. This includes a 7-year history for all state and federal databases and the National Sex Offender Registry.

Janitronics performs in-house quarterly audits to ensure accurate recording, proper storage and compliance with all retention rules for documents of our employees.

The procedure for hiring individuals is as follows:

- Applications from individuals are collected and reviewed.
- We process employment applications and initiate background checks.
   This entails a Social Security database check and any other relevant information which needs to be verified.
- We contact those candidates who meet our hiring needs and make an offer of employment.

The candidate must then successfully meet all requirements of the Employment Eligibility Verification (I-9) Form as established by the Department of Homeland Security.
